

Form of application by a person to have his/her name entered on a local authority's list of persons entitled to sell non-medical poisons included in Part II of the Poisons List.

NOTES

- (1) In the case of a sole proprietor state the full name of that person. *Up to two other persons may be nominated as the 'deputies' of the named person to entitle them also to sell 'Part II poisons' from the same premises. See note (4).*

In the case of a partnership the application must be made in the name of one of the partners. Please state the full name of the partner concerned, followed by the trading name (if any) of the partnership. *Up to two other partners, or other persons, may be nominated as the 'deputies' of the named partner to entitle them also to sell 'Part II poisons' from the premises. See note (4).*

In the case of a limited company, or other corporate body, the registered name of the company or organisation should be stated. *In this case one or two 'deputies' MUST be named at (4) since a limited company may ONLY sell 'Part II poisons' through its nominated deputies.*

- (2) State type of business carried on (e.g. 'Hardware Store', 'Garden Centre' etc.)
- (3) State the address of the premises from which poisons are to be sold. *Where poisons are to be sold from more than one outlet a separate application form should be completed, and fee paid, in respect of each address.*

- (4) Up to two 'deputies' may be nominated to sell 'Part II poisons' in the absence of the person named at (1). If you choose to nominate one or two deputies, state the full names of each. Corporate bodies MUST nominate one or two deputies as the individuals through whom all 'Part II poisons' sales will be made, since a corporate body can only act through its employees.

Not more than two deputies may be nominated. To authorise sales by more individuals, a separate application must be made (and fee paid) to register each additional person as a registered seller in his/her own right.

- (5) This form should be signed by the person named at (1) or, in the case of a corporate body, a senior representative of the organisation.
