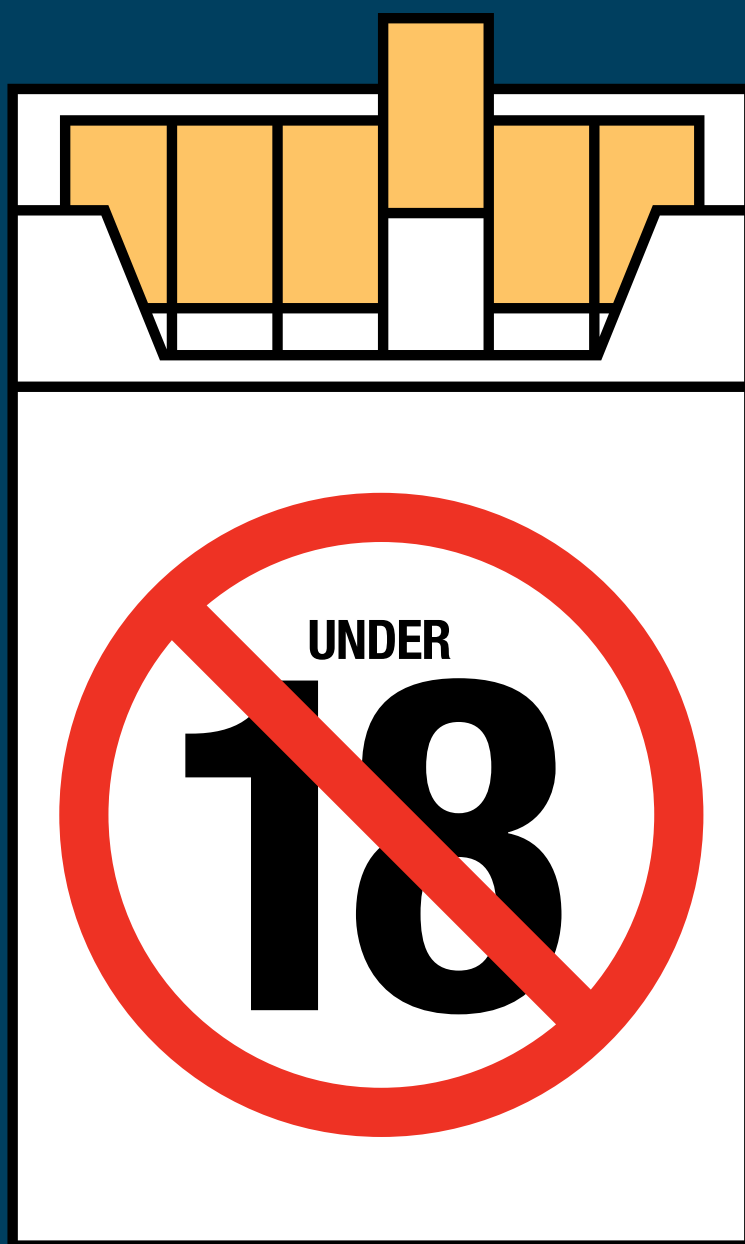


**THE LAW IS CHANGING
ON 1ST OCTOBER 2007**



THE LAW IS CHANGING

From 1st October 2007 it will be against the law to sell tobacco products to anyone under the age of 18 in England and Wales. The change will include cigarettes, cigars, tobacco for roll-your-own and pipes as well as rolling papers sold both over the counter and through vending machines.

WHY IS THE LAW CHANGING?

Most addicted adult smokers began smoking as teenagers. The law is changing to help prevent children and young people from becoming addicted and experiencing the serious health dangers of smoking.

By choosing to sell tobacco you have to comply with a number of legal duties, one of which is not to sell products to those under the minimum age.

The reasons for this become clear when you consider that:

- One in two lifelong smokers will be killed by their addiction.
- The younger a smoker starts the more likely they are to be killed by their addiction.
- Someone who starts smoking at 15 is three times more likely to die from cancer due to smoking than someone who starts smoking in their mid-20s.

WHAT DO I NEED TO DO TO COMPLY? (THE LEGAL REQUIREMENTS)

From 1st October 2007:

- You must not sell tobacco products to anyone under the age of 18. This will replace the current law where it is illegal to sell tobacco products to anyone under the age of 16.
- You must replace any existing signage (statutory notice) with a sign stating the new legal age restriction for tobacco products. The sign should be placed in a visible position, where it can be seen by anyone wishing to buy tobacco products, and keep to the following guidelines.

SIGNAGE FOR OVER THE COUNTER SALES

We have enclosed a sign for you to use. If you choose to produce your own or use another, to comply with the law:

- It must state, 'It is illegal to sell tobacco products to anyone under the age of 18'.
- It must be at least A3 in size (420mm x 297mm) and have letters at least 36mm high.

SIGNAGE FOR VENDING MACHINE SALES

All tobacco vending machines must also display an updated sign. To comply with the law, your vending machine sign:

- Must state, 'This machine is only for the use of people aged 18 or over'.
- Must be at least 60mm x 100mm, with letters at least 6mm high.
- Must be clearly visible to anyone using the machine.

Your tobacco wholesaler or vending machine provider should be able to provide you with a sign if they haven't done so already.

HOW WILL THE CHANGE IN LAW BE ENFORCED?

Trading Standards Officers will continue to enforce the law relating to the sale of tobacco products to under-age consumers.

The penalty for selling tobacco products to someone under the age of 18 from 1st October 2007 is a fine of up to £2,500.

Both the sales person and the business owner could be liable for any illegal sales, even if it was believed that the purchase was being made on behalf of an adult, or if the person looked like they were over 18.

Failure to display the statutory notice can result in a fine of up to £1,000. This applies both to over the counter and vending machine sales.
