AGREEMENT TO LICENCE CONDITIONS

In the matter of the review of the licence held by Amber Taverns Ltd for the The Old Bank (formerly Cuba Cuba), 50 Yorkshire Street, Oldham, the premises licence holder requests the Licensing Authority to take note of the agreement reached with the applicant for review, the local weights and measures authority and the party making representations in the review, Greater Manchester Police, as follows:

1. That the applicant would voluntarily accept the following conditions be placed upon the licence for this premises:

"None of the following promotional activities of alcoholic beverages shall be offered to customers between 21:00hrs and the time at which the premises close for business:

- *reward schemes that are only redeemable over short periods;*
- *drinking games;*
- *promotions that involve large quantities of free drinks;*
- *entry fees that are linked with unlimited amounts of drinks;*
- *promotions that are an incentive to speed drinking or to encourage people to consume alcohol quickly;*

- *promotions limited to unpredictable events;*
- *promotions that encourage or reward purchase or drinking of large quantities of alcohol in a single session;*

If the holder of the Premises Licence intends to sell any alcoholic beverage between 21:00hrs and the time at which the premises close for business at a price significantly less than the price charged for that product under the pricing structure adopted by the Premises Licence holder, it will carry out a risk assessment of the potential risks, and the measures to control those risks, associated with such a promotion.

Unless otherwise agreed in writing with the Greater Manchester Police, a minimum of 2 SIA registered door supervisors will be on duty at the premises from 2000 until close on Friday (into Saturday morning) and on Saturday (into Sunday morning). The requirement for additional door supervisors at all other times will be risk assessed in partnership with Greater Manchester Police and door supervisors will be employed at such times and in such numbers as deemed necessary by the risk assessment"

2. The current condition, which states:
"No irresponsible sales promotions of alcoholic beverages shall be offered to customers" shall be replaced by the above conditions and shall be removed from the licence
3. That, if accepted by the Licensing Authority, the local weights and measures authority would withdraw its proposed conditions contained within its application.
4. That, if accepted by the Licensing Authority, the Greater Manchester Police would withdraw its representations in relation to the review.
5. That, the parties to the proposed hearing in this matter having signed this agreement, requests the Licensing Authority to determine the application accordingly in accordance with Paragraph 7, Schedule 4 of the Licensing Act 2003 (Hearings) Regulations 2005.

6. That, as agreement has been reached, the parties consider that a hearing is unnecessary and ask the Licensing Authority to proceed to determination in accordance with Regulation 9 of the Licensing Act 2003 (Hearings) Regulations 2005.

The premises licence holder and the responsible bodies that are party to this review would like to take this opportunity to thank the Licensing Authority for their determination in this matter.
